**RSW 118 Public Participation**

**Mayor Read, South Wairarapa District Council**

Mayor Read addressed the Committee on the coastal subdivision report to the Environment and Rural Services and Wairarapa Committees. He said the report appeared to be

biased towards the prohibition of subdivision and development on the Wairarapa coast and the three Wairarapa Mayors were concerned about that. Mayor Read referred specifically to objectives in the Regional Policy Statement.

Mayor Read conveyed the concerns of the Mayors that the development of the Wairarapa and the creation of jobs and wellbeing for its population were being jeopardised through this negativity. He also believed that no comparison could be made between the potential subdivision similarities of the Wairarapa coastline and the ribbon pattern development along the Kapiti coast.

Members noted that this issue was to be further considered later in the meeting.

**(2) Joe Taylor, Wairarapa Federated Farmers**

Mr Taylor said that the Environment Committee's recommendation to vigorously oppose coastal subdivisions where they adversely affect the natural character of the coastal environment was contrary to the Resource Management Act whereby the Council had not involved the coastal dwellers and landowners in any consultation process prior to preparation of the report.

Mr Taylor also referred to policies in the Proposed Regional Soil Plan relating to sustainable land management. Comment was also made on schemes such as the Whareama Catchment Scheme and the promoting of sustainable land management through landcare groups.

**(3) Jim Hedley**

Mr Jim Hedley addressed the Committee on the Whakawiriwiri Drain and matters associated with its upgrade, and also commented on aspects of the recent prehearing meeting.

It was noted that the upgrade of three access culverts was presently the subject of a resource consent application process.

Mr Dalziell stated that pest plants and animal pests, other than rooks and possums, were becoming an ever increasing problem and a stronger line towards total eradication should be followed.
