PT 156 **Public Participation**

Mr J Ward. East by West Company

Mr Ward said the Eastbourne Market Research Report had concluded that the most likely improvement to bring new users to public transport in the greater Eastbourne area is the provision of more frequent ferry sailings.

Mr Ward said the East by West Company believes a second ferry is necessary and is prepared to invest in the significant capital cost of a new ferry if it has the support of the Greater Wellington Regional Council.

The Company is eager to develop additional routes including the trialing of a new commuter service from Petone to the City. Mr Ward asked whether Council officers would be prepared to look at options and costs.

Following questions Councillor Turver asked officers to investigate and report back on the East by West proposals at the March Passenger Transport Committee meeting.

Mr B Efford, Transport 2000+

Mr Efford said he agreed with the recommendations included in the agenda for today's meeting about the Fares Review Update. The restructured fares will encourage a greater use of public transport and this will result in environmental benefits and an improvement in traffic flows in the region.

Mr Efford also congratulated members for the progress on the new Petone Station development.

Mr Randle

Mr Randle said he was making representations on behalf of Mr Keay, organiser of the petition opposing the fare increases. Mr Keay had been unable to attend today's meeting. Mr Randle said while Council had accepted some of the points raised in the petition there was disappointment some children's fares will increase.

- (1) *That the new fare boundaries and fares be implemented as agreed by the Committee on 12 June 2003, except that \$1.00 for adults and 50 cents for children be adopted as the standard one section cash fare throughout the Region, recognising that this may cost the Council as much as \$300,000 per annum in increased contract payments to operators, subject to the approval of the extra funding.*
- (2) *That the already-implemented changes to the proposals as described in section 5 above, be noted.*
- (3) *That all fares be reviewed in two year's time.*

Amendment

That \$1.50 for adults and 70 cents for children be adopted as the Standard One Section cash fare throughout the region.

The above amendment was **LOST** on a show of hands 3 votes in favour and 6 opposed.

The motion as moved by Councillor McDavitt and seconded by Councillor Aitken was then put and **CARRIED** on a show of hands 7 votes in favour and 2 opposed.

Councillor Thomas dissented.

Councillor Turver said that having completed the fares review update would officers report to the next meeting on future proposals for passenger transport planning in the region.
